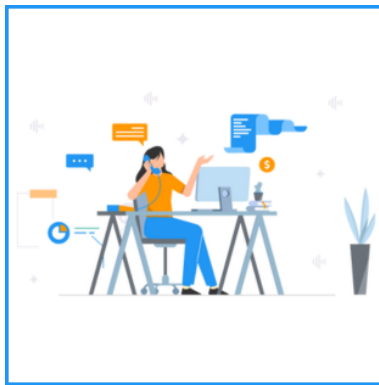

COMMUNICATIONS



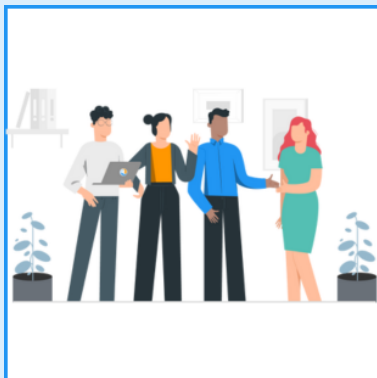
Automatically Log Event Emails

System-triggered emails related to event activity are now logged as interactions giving you a complete view of communications, without any extra work.

- Emails tied to registrations, cancellations, modifications, and reminders are now tracked on the person's profile
- Logged details include recipient, subject, event name, and timestamp
- Entries appear under the contact's Interactions tab—fully searchable and reportable

This ensures full visibility into event communications and strengthens your audit trail for each participant.

RELATIONSHIPS



Invite Multiple Users in One Go

You can now invite several people at once to become Engagifii users—saving time and simplifying onboarding for large teams or new member groups.

- Select the user type (e.g., Admin, Viewer, Event Manager) before sending
- Each invitee receives a personalized, secure login invitation
- The system prevents duplicate invitations and flags existing users automatically

This update makes it much easier to roll out access for new member organizations, newly elected members, departments, committees, or entire organizations in a single action.

Control Staff Analysis Reports

You can now control the visibility of headers, positions, and tracking colors to tailor how staff analysis appears—whether you're preparing internal reviews or sharing externally.

- Show or hide staff analysis headers per report
- Toggle position labels and color indicators
- Get cleaner layouts or deeper context based on your audience

This enhancement helps ensure your reports strike the perfect balance between clarity and depth.

EVENT SESSION VISIBILITY CONTROLS

Get ready for a more tailored and secure registration experience. Admins will soon be able to set visibility rules for each event session just like you can on bundles.

Control access by person type, tags, organizations, or committees to ensure only the right people see the right sessions. This protects sensitive content and improves registration flows for both clerks and participants.

PUBLIC EVENT REGISTRATION LINKS

Simplify sign-up for new users without requiring them to log in first. This new enhancement lets you create event registration links tied to specific person types and workflows. Once someone clicks a link, they're routed to the correct registration experience automatically.

It's perfect for adding to websites, emails, or outreach materials, and ensures the right people land in the right place, every time.

MODIFY & CANCEL EXHIBITOR REGISTRATIONS

Exhibitor admins will be able to modify or cancel exhibitor registrations directly within the system — no more spreadsheets or manual recalculations. Whether you're adjusting booth assignments, updating booth staff, changing event sessions or bundles, or applying modification or cancellation fees, the system will automatically calculate downstream revenue impact and create relevant revenue instruments, keeping your financials clean and compliant.

If an exhibitor cancels, Engagifi will now issue credit notes or refunds automatically based on your cancellation policy. Every action is tracked in a detailed activity log, giving you full control and a transparent audit trail — all in just a few clicks.

BOOTH MANAGEMENT UPGRADE

A new Assignment tab will separate booth setup from exhibitor assignment—making the process cleaner and easier to manage. Admins will be able to assign booths before purchase, view preferences submitted by each exhibitor, and toggle between exhibitor-, booth-, and booth type-centric views. With improved status tracking, filtering, and export options, this update supports large-scale event planning while eliminating confusion around assignments and availability.
