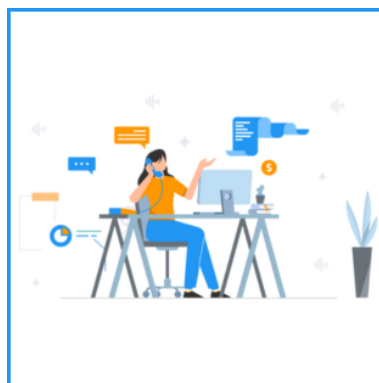
We've rolled out new tools and thoughtful improvements that help you:

## Bill Notifications With Better Tracking

When using the **Save and Notify** option in Staff Analysis, you'll now see exactly **who** was notified and **when**. This new tracking system adds transparency to every message you send. With this update:

- The pop-up will now display the recipient's name and timestamps
- Edited analyses reflect the last sent notification
- A full log of past notifications is saved on the Activity Tab

No more guesswork or follow-up emails just to confirm, everything is right where you need it.

## Faster and Clearer Registration

We've improved the **Complete Your Profile** and **Self-Registration** experiences to make onboarding smoother for new users and reduce support needs for your team.

- The redesigned interface is cleaner and more consistent across devices

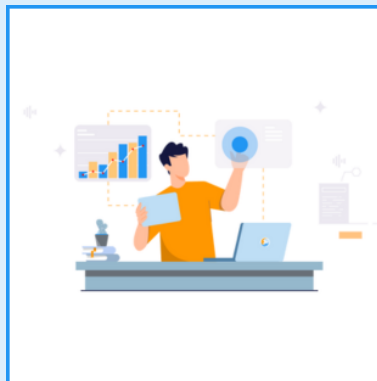
## Assign Training Credits Manually

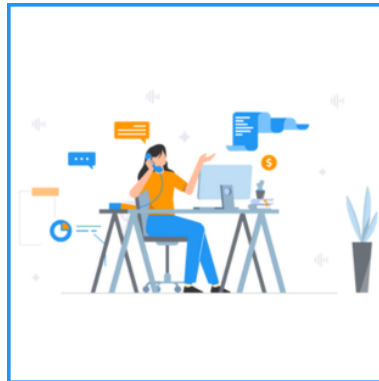
## Know What Requires Your Review

A new **Pending Actions** feature is now available giving your team a focused list of what's still waiting on you. Here's how it helps:

- Automatically surfaces bills that are assigned to you but haven't been analyzed
- Removes the need to manually track open individual tasks
- Helps ensure no critical analysis is missed

It's a purpose-built workflow tool designed to improve clarity and accountability within legislative workstreams.

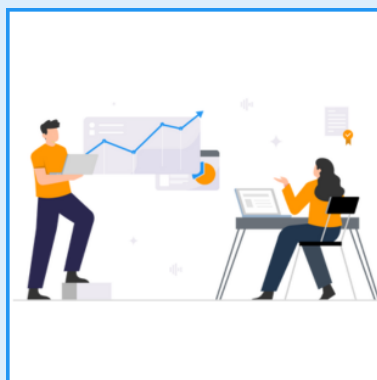
### Send Invoice Reminders Instantly

Following up on unpaid invoices just got easier. You can now trigger personalized invoice reminders directly from the **Aged Receivables Report**, speeding up collections without extra steps.

- Select one or multiple open invoices—filter by age (0–30, 31–60, 90+ days)
- Reminders include a secure “Pay Now” link for each buyer along with a personalized note.
- All reminder activity is tracked and time-stamped in the Activity Log

This gives your team a faster and more organized way to follow up on overdue payments.

## LEGISLATION



### Bill Titles Now Easier to Read

To help you scan and understand legislative data faster, bill titles now display the **Brief Summary** instead of the longer **Caption Text**. This change brings:

- Shorter, more readable bill names

- Increased clarity when reviewing reports & alerts
- Less time spent parsing lengthy legal text

A simple but powerful improvement, especially for staff managing large volumes of tracked legislation.

## *And, that's not all...*

We've also rolled out key enhancements for **tracking legislation in Nevada** to better support reporting and member engagement in the state.

- **Legislative Reports Just Got Smarter**

Reports now include Last Committee Action Date and Action Type as standard fields. These details provide immediate legislative context—no more toggling back and forth to get the full picture.

- **More Filters on Bill Lists**

You can now filter and export bill lists by Committee Action Date and Type. This enhancement makes it easier to prioritize your follow-up, status report, and share updates with confidence.

- **Better Hearing Visibility**

Hearing entries are now clearly labeled as either a Bill Hearing or a Work Session. That means less ambiguity when reviewing timelines and fewer mix-ups when scheduling or preparing talking points.

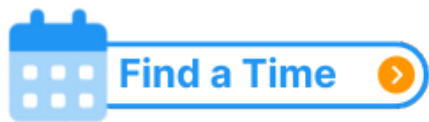
- **Track Exhibit Links Seamlessly**

Uploaded exhibits now appear directly in the Bill Timeline, complete with clickable links and titles. These links are also searchable, helping you access what you need, right when you need it.
